


Coffee, Tea & Drink Ingredients July 14, 2011 COFFEE / TEA

Coffee

Since coffee is not produced in Japan, all coffee beans rely on imports.

Main raw coffee bean import partners in 2010 are 1st Brazil (123,073 tons), 2nd Colombia (79,060 tons) and 3rd Indonesia (59,068 tons) on a volume base. The import value is 116.4 billion yen, and the number one share is Brazil (28.1%), 2nd Colombia (26.5%) and 3rd



Guatemala (10.3%). In both volume and value, the top 3 countries make over 60% of the total amount. Importing countries add up to over 40.

Coffee has become necessary for Japanese people's daily lives, and coffee consumption in Japan is stable. Also, since coffee has the same amount of polyphenol as red wine, its effects on health are getting attention. The import price of raw coffee beans fluctuates depending on the weather and speculation. Also, the exchange rate affects the price greatly, so it is hard to predict. On a quantity basis, although young people are not drinking much coffee due to the preference change and falling population, because there are more demand at homes and work places and coffee is starting to sell as a healthy drink, it is predicted to make a small growth.

Regular coffee and instant coffee by country and import volume is as below.

With regular coffee, foreign companies are increasing its import and the import volume of raw bean was 7,510 tons, 1.7% of the total amount. Also, with imported coffee, there are end products for customers and intermediate products. In 2010, the import volume was 19,357 tons in raw bean quantity, 4.4% of the total amount.

Tea

Teas are imported in two different ways and one is where containers of net weight under 3kg are directly imported and the other is where the bulk is imported as an ingredient of the tea. Most of green tea, black tea, and partly fermented tea are imported in bulk, and it takes up 80%~90% of each import volume.

The main importing countries of black tea are China, Sri Lanka and India, and they are the top 3. These 3 countries make 87% (2010) of the whole import value.

JAPAN TODAY

In Japan, black tea beverage industry is getting great attention. New products are being introduced, and the market is becoming active. The appeal is in the variety of types and flavor, along with reducing sugar to cut calories but have sweetness. Itoen's "Tea's Tea New York" sold 5 million boxes (120 million bottles) in the first 11 months. The



reason behind the success was its scent of fresh fruits and lightly sweetened taste. It shows consideration to health reducing its calories and cutting down 50% of the caffeine. As a result, it is getting support from both men and women in their 30s~40s along with people in their 20s. With the attention attracting domestic market in the background, the import value and quantity of tea in 2010 both increased 14% year to year doing very well.
